



**NOTES:**

1. The works are to be undertaken in accordance with Highway Agency Manual of Contract Documents for Highway Works (MCDHW).
2. All dimensions are in millimetres unless otherwise shown.
3. All concrete shall be standard mix ST4 unless otherwise stated.
4. Allow for up to 1.5m excavation for all drainage pipework for pricing purposes
5. Allow for the reinstatement of all existing surfaces on completion.
6. All drainage features to be to D400 Carriageway loading.
7. Allow for the repositioning / replacement of all kerbing / edging as required during the works.
